INVITATION FOR QUOTATIONS

Subject: Invitation for Quotations for Repair and Restoration of Cane Chairs at K Gudi Nature Camp

Sealed quotations are invited from eligible and experienced furniture repair agencies, cane furniture manufacturers, artisans, or contractors for carrying out the repair and restoration of cane chairs at **K Gudi wilderness camp**

1. Scope of Work

The successful bidder shall undertake the following works:

- Inspection and assessment of the existing cane chairs.
- Replacement of damaged or worn-out cane weaving with premium-quality natural cane.
- Repair and strengthening of wooden frames, armrests, legs, and joints.
- Replacement of damaged wooden components, wherever required, using matching wood.
- Sanding, polishing, varnishing, and finishing of repaired chairs.
- Tightening of all joints and ensuring structural stability.
- Transportation of chairs, if required, to and from the repair workshop.
- Delivery of the repaired chairs to K Gudi Nature Camp in good condition.

2. Quantity

The work shall cover approximately 122 Nos of **cane chairs**. The actual quantity may vary based on the inspection and approval of the Competent Authority.

3. Eligibility Criteria

The bidder shall:

- Be an experienced cane furniture repair agency, manufacturer, or artisan.
- Possess valid GST registration and PAN (where applicable).
- Have experience in repairing and restoring cane or wooden furniture.
- Have adequate skilled manpower and tools to execute the work.
- Not have been blacklisted by any Government Department, Public Sector Undertaking, or Autonomous Body.

4. Submission of Quotations

The quotation shall include:

- Item-wise repair charges.
- Transportation charges, if any.
- Applicable GST and taxes.
- Time required for completion of the work.
- Details of similar works executed.
- Warranty on workmanship.

5. Inspection

Interested bidders may inspect the cane chairs at **K Gudi wilderness Camp** during office hours before submitting their quotations. Prior appointment may be obtained from the Resort Manager.

6. Completion Period

The repair work shall be completed within **15–30 days** from the date of issue of the Work Order.

7. Payment Terms

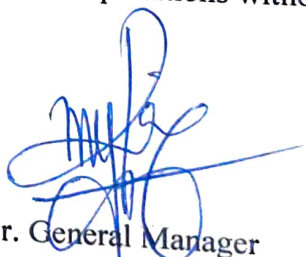
Payment shall be released after satisfactory completion of the repair work, inspection, and certification by the authorized officer, subject to submission of the tax invoice and other required documents.
